

Guidelines for using the Internet

Introduction

The Board of Governors will ensure that Largymore Primary school has a policy on the safe, healthy, acceptable and effective use of the Internet and other digital tools e.g. iPads, digital cameras, mp3/mp4 players and acceptable use of mobile phones and gaming hand-helds which have downloadable capabilities e.g. Nintendo DS Lite or PSPs. They also promote safe and acceptable practices for all staff and pupils.

General

- Use of ICT in the Northern Ireland education community must be in support of the aims and objectives of the Northern Ireland Curriculum
- All users must comply with all copyright laws
- All users must limit their use of the Internet for school related purposes examples
 of this include the use of email, the use of the Internet to investigate and research
 school subjects and staff using the Internet to further develop their professional
 development
- All users are expected to behave in an appropriate manner when communicating with others
- All users must be aware that the use of the Internet in schools is a privilege and not a right and this privilege will be withdrawn if it is misused
- All users must respect the hardware and software that has been made available to them
- All users must respect the work of others

<u>Pupils</u>

- Pupils must not enter the folders or files of anyone else
- Pupils must not alter another pupil's work without their permission
- Pupils must be aware that teachers have the right to enter any pupil folder in their own class
- The ICT Co-ordinator and Principal reserve the right to enter any pupil's folder
- Pupils must not use the Internet for unapproved purposes

- When using online collaboration and communication tools, such as Fronter and Seesaw, pupils must communicate in a polite and sensible way
- Pupils must not share their own or anyone else's personal information, such as full name, address or phone number, while using the Internet
- Pupils must sign the school Acceptable Use Agreement with their parent/guardian
- Pupils should be discouraged from bringing mobile phones and hand-held gaming consoles with downloadable capabilities to schools on the grounds that they:
 - o are valuable and may be lost or stolen.
 - o are capable of storing images that are inappropriate

Parents

- Parents should be aware that the access to the Internet provided to staff and pupils in school has limiting security features
- Parents should be aware that the use of the Internet in school is supervised by a member of staff at all times
- Parents should be aware that there will be no use of the Internet without the supervision of staff and that this will be in full view of others, e.g. the classroom or the ICT suite
- Parents should, in co-operation with staff, make pupils aware of the rules and expectations within this document
- Parents should sign the school Acceptable Use Agreement with their child/children
- Parents should be aware that the use of ICT is complimentary to the teaching already done – i.e. the use of computers in the classroom is a tool
- Parents should be aware that children's full names will not be available online at any stage but some indication of work they do could be added to any online work that becomes available on the school website
- Parent should be aware that no photographs of pupils will be available online without parents giving their permission
- Parents should discourage pupils from bringing mobile phones to school on the grounds that Internet access becomes very difficult to police
- Parents should also be aware that social networking sites such as Facebook adhere to a strict 'over 13s' age policy and while access to these sites is denied in school it is the parents responsibility to monitor their access at home.

- Network administrators reserve the right to review files and communications to maintain system integrity and ensure that the users are using the system responsibility – they will respect the right to privacy whenever possible
